Kevin James Jarvis, age 26, of Bishop, California, was found unresponsive and without vital signs at a family members Mammoth Lakes home. Mammoth Lakes Police Department and Mono County Paramedics were dispatched to the residence in Mammoth. When units arrived on scene, it was determined that Mr. Jarvis was deceased. Mono County Sheriff's deputies were dispatched to the scene to begin the coroner's investigation. The final cause of death was determined as a drug overdose. The final cause of death was confirmed by autopsy and toxicological results.

Mammoth Lakes Police Department and Mono County Paramedics were dispatched to the residence in Mammoth. When units arrived on scene, it was determined that Mr. Greenstein was deceased. Mono County Sheriff's deputies were dispatched to the scene to begin the coroner's investigation. The final cause of death was determined as acute narcotic intoxication. The final cause of death was confirmed by autopsy and toxicological results.

RE: Introducing the CodeRed Emergency Alert System Mobile App

Mono County utilizes what is known as the CodeRed Emergency Alert System when a critical incident or emergency situation takes place within the county. This system is a database of resident and citizen information for use only in critical and emergency situations. When residents and citizens enter their information into the CodeRed Emergency Alert System, they are added to a nationwide database set exclusively for emergency community alerts in emergency situations. To register for the CodeRed emergency alerts, log on to www.monosheriff.org and click on the CodeRed Community Notification System link.

The CodeRed system has also joined the technology bandwagon by introducing the release of the new CodeRed Mobile Alert Public Safety app for smart phones. This app will not only benefit the residents of Mono County but also the travelers and visitors to the area. Smart phones with the new app will be alerted with a push notification along with the voice file of the alert for up to 24 hours after the alert has been issued. This is a free app and is currently available for the Apple iPhone via download from iTunes. The Android app will be available soon. Dr. Andrew Bourne, age 46, of Mammoth Lakes, was found deceased by his spouse on the afternoon of Tuesday, January 24th.

An autopsy was conducted on the morning of Friday January 27, 2012 by the Orange County Sheriff's Department Coroner with results confirming that Dr. Bourne did commit suicide. There is no evidence to suspect foul play in his death. Final cause of death is still pending toxicological results which could take several weeks or longer.

RE: Residential Explosion and Fire

On Friday February 3, 2012 at approximately 8:53 p.m. the Mono County Sheriff's Dispatch received numerous 911 calls regarding an explosion and a residential structure that was on fire at the Mountain Warfare Training Center (MWTC) Base Housing.

The following agencies were dispatched to the scene: Antelope Valley Fire Department, MWTC Fire Department, Mono County Paramedics, Mono County Sheriff's Department, California Highway Patrol, MWTC Police Department, along with the East Fork Fire Department out of Nevada.

Upon arrival, medical personnel assisted the victims and fire personnel battled the fire, which was still engulfing the residence. Careflight responded and two of the victims were airlifted to hospitals out of the area, with another victim being pronounced deceased at the scene.

Mono County Social Services responded and opened the Walker Community Center for use as a shelter, if needed, and the Red Cross was contacted out of both California and Nevada.

RE: Residential Break-In and Pursuit in Chalfant

On Thursday, March 1, 2012 at approximately 7:00 a.m., Mono County Sheriff's Dispatch received a 911 call from a 9-year old child stating someone had broken into his house in Chalfant through the bedroom window and was causing harm to his mother. The suspect was reported to be armed with a knife. Mono County Sheriff's Deputies along with California Highway Patrol Officers were dispatched to the scene.

CHP arrived at the residence first and determined that two of the occupants of the house, a mother and child, had escaped and were safe in a neighbor's house. A neighbor was currently over at the residence helping get another infant child out of the house safely. The suspect, Bryce Williams, age 29, of Bishop, CA, fled the scene in a blue Ford Focus.

Mono County Sheriff's Deputies spotted Mr. Williams vehicle driving at a high rate of speed southbound on Hwy 6 headed toward Bishop. Mono County Sheriff Units along with additional CHP Units and Inyo County Sheriff Units pursued Mr. Williams as he entered Bishop. Mr. Williams exited his vehicle at an apartment complex in Bishop and was ultimately found hiding in one of the apartments. Inyo County Sheriff's Deputies arrested Mr. Williams without incident. Mr. Williams was transported to Northern Inyo Hospital for medical clearance and then transported to the Inyo County Jail in Independence for miscellaneous charges. Some of the charges pending against Mr. Williams in Mono County will include inflicting corporal injury, burglary, false imprisonment, and child cruelty.

RE: Single Vehicle Accident into Topaz Lake

On Friday, March 9, 2012, at approximately 3:30 pm, Mono County Sheriff's Office Dispatch received a call regarding a possible vehicle off the highway and into Topaz Lake around Highpoint Curve on Hwy 395.

Mono County Sheriff's Deputies, Antelope Valley Fire Department, Mono County Paramedics, California Highway Patrol, and Douglas County Sheriff's Deputies and Dive Team were dispatched to the scene. A single vehicle was located completely submerged in Topaz Lake with one occupant inside the vehicle. Douglas County Dive Team with the assistance of Mono County Paramedics located the occupant of the vehicle and determined that they were deceased and would recover the body from the vehicle. Efforts are currently under way to retrieve the vehicle from the lake.

RE: Missing hiker found deceased near Coleville

On the afternoon of Thursday, March 22, 2012, Mono County Sheriff's Dispatch received a call regarding an overdue hiker around the hills of Coleville. Carial McCall, age 78, of Coleville, was reported missing by his son when he did not return home from a short hike in the hills around his home.

Mono County Deputies and Antelope Valley Fire Department responded to Mr. McCall's residence and began a search inside and out with no results as to the whereabouts of where Mr. McCall was. The Mono County Sheriff's Search and Rescue (SAR) team was then dispatched to respond to aid in broadening the search area.

Search efforts continued throughout the night. On Friday, March 23, additional agencies including the California Rescue Dog Association (CARDA), personnel from Alpine County, and a CHP helicopter joined the search to locate Mr. McCall. The search continued throughout the day and night with negative results into the location of Mr. McCall.

By Saturday, March 24, the search team included personnel from Mono, El Dorado, and Inyo Counties including several additional CARDA dog teams. At approximately, 1:00 pm, Mr. McCall was found deceased in steep terrain about a mile from his home. His death is under investigation by the Mono County Sheriff's Office but appears to be of natural causes. Final cause of death is pending autopsy and toxicology reports.

RE: MONET bust turns into a high speed pursuit

On Saturday, April 28, 2012, the Mono County Narcotics Task Force (MONET), along with the assistance of the Inyo County Narcotics Task Force (INET), Mono County Sheriff's Department, Mammoth Lakes Police Department, California Highway Patrol, Inyo County Sheriff's Department and the Bishop Police Department, concluded an investigation in Mammoth Lakes into the transportation and sales of methamphetamine.

MONET agents arranged to purchase methamphetamine from Hector Pacheco, Jr., age 34, of Ontario, CA. Mr. Pacheco met with the undercover agents and completed the transaction sale. As the transaction was completed, an arrest team attempted to take him into custody. Mr. Pacheco got into his vehicle and rapidly accelerated away nearly striking a member of the arrest team. As Mr. Pacheco fled the scene, he struck a Mono County Sheriff's patrol unit that was attempting to stop him. He fled at a high rate of speed down Old Mammoth Road failing to stop at two controlled intersections.

Mr. Pacheco continued to flee outside of the Town of Mammoth Lakes traveling southbound on to Hwy 203 and onto Hwy 395 at speeds in excess of 100 miles per hour. Law enforcement officers pursued him from Mammoth Lakes to just outside of Bishop. His vehicle was stopped by law enforcement officers using the PIT maneuver (a pursuit tactic used to force a fleeing vehicle to stop). Mr. Pacheco was arrested without further incident and transported to the Mono County Jail in Bridgeport. As a result of the arrest, MONET agents seized a ½ pound of methamphetamine. Mr. Pacheco is currently in custody at the Mono County Jail facing charges of felony evading, assault with a deadly weapon, and transportation and sales of narcotics.

MONET would like to thank all the agencies that assisted with this case. It was a successful team effort.

RE: Ongoing Search and Rescue efforts currently in progress to find a missing solo backcountry skier

On Tuesday, May 1, 2012, at approximately 4:30 pm, Mono County Sheriff's Dispatch received a call regarding a black Honda Civic that had been parked near Poole Plant Road off Hwy 120 West since April 19th.

Mono County Sheriff's Deputies responded to the area and found a note left under the windshield wiper of the vehicle stating that a solo backcountry skier was heading up Mount Dana Couloir for the day to ski down Cocaine Chute. With the warmer temperatures, even in the higher elevations, snow conditions have been affected and several avalanches have been seen in this area over the past several weeks.

Boris Avdeev, age 31, of Ann Arbor, Michigan, an experienced backcountry skier, has not been heard from since setting out on his solo backcountry ski trip on April 19th. On Wednesday, May 2, 2012, Mono County Sheriff's Search and Rescue (SAR) ground teams were dispatched to the Cocaine Chute area to start performing a lower chute search to see if they could locate Mr. Avdeev. The ground teams were unable to locate him. On Thursday, May 3, 2012, additional resources were requested including a helicopter from Fallon Air Station, two rescue dog teams, and a mutual aid request for Inyo County Sheriff's and Yosemite Search and Rescue teams to help aid in the search efforts.

This is currently an ongoing Search and Rescue operation and more details will be given as they become available. If anyone has any information regarding this current operation that may aid the search teams, please contact Mono County Sheriff's Department Dispatch at (760) 932-7549.

RE: Fatal Traffic Accident on Hwy 395

On Saturday, June 30th, 2012, at approximately 11:30am, Mono County Sheriff's Department dispatch received a call regarding a traffic accident that had occurred on Hwy 395 at Obsidian Dome Road.

Mono County Sheriff's Deputies, California Highway Patrol, Mono County Paramedics, and June Lake Fire Department were dispatched to respond to the accident. When Mono County Sheriff's Deputies arrived on scene, a gray Jeep SUV was on its side in the middle of the intersection at Hwy 395 and the Obsidian Dome Road turnoff. A green Dodge Caravan, with damage to the driver's side door, was resting on the east dirt shoulder. Witnesses of the accident stated the Dodge Caravan was traveling eastbound from Obsidian Dome Road onto Hwy 395 without stopping to observe if there was any oncoming traffic. The Jeep SUV, unable to stop to avoid the collision, struck the caravan.

The driver of the Dodge Caravan, Randy Sly, age 53, a transient of the Mammoth Lakes area, was killed as a result of the collision. Passengers of the Jeep SUV suffered major injuries and were transported to Mammoth Hospital for treatment. Autopsy results indicate that Mr. Sly's cause of death was due to traumatic injuries caused by the traffic collision. Accident details are currently under investigation by the California Highway Patrol.

RE: Overdue Climber found deceased in the Sawtooth Range

On Tuesday, July 3, at 5:50 pm, Mono County Sheriff's Department dispatch received a call reporting a climber that was overdue from a planned traverse of several peaks in the Sawtooth Range from Matterhorn Peak to Blacksmith Peak. This range is the boundary between Mono County and Yosemite National Park.

Mono County Sheriff's Deputies, along with team members from the Mono County Sheriff's and Yosemite National Park Search and Rescue (SAR) Teams, responded to the Matterhorn Peak area to search for the overdue hiker, Michael J. Ybarra, age 45, of Los Angeles, CA. Search teams found that Mr. Ybarra had signed the summit register at Matterhorn Peak, but not at Cleaver Peak, thus intensifying the search efforts between the two peaks.

As the search expanded into a multi-day, multi-agency search, a crew from the National Guard out of Sacramento was requested to aid in the search efforts via a Blackhawk helicopter. The helicopter crew located Mr. Ybarra, deceased, on the steep western flank between Matterhorn Peak and Cleaver Peak. Yosemite National Park and Tuolumne County personnel recovered Mr. Ybarra's body on Wednesday, July 4th.

Final cause of death is pending autopsy results but appears to be the result of a solo climber fall.

RE: Two Adults Arrested For Child Endangerment

On Friday July 13, 2012 at approximately 8:20am, the California Highway Patrol (CHP) dispatch center notified the Mono County Sheriff's Department of a possible child abduction that just occurred in the Bishop area. A caller told the CHP that two white males just placed a young female juvenile into the cargo area of a tractor trailer and proceeded northbound on Highway 395.

Mono County deputies located the semi-truck on Highway 395 near Benton Crossing Road and conducted a traffic stop on the truck. The deputies searched the locked refrigerated cargo trailer and located an eleven year old female hiding amongst the loose cargo.

During the investigation, it was determined that Mr. George Lewis Arciero, age 52, a resident of Apple Valley Ca., had taken his granddaughter to work with him for the day (the granddaughter was the juvenile located in the locked refrigerated cargo trailer).

While in Bishop, Mr. Arciero picked up a Mr. Jason Ray Jernigan, age 33, a resident of Bishop, at which time they placed the female juvenile into the refrigerated cargo trailer and locked it prior to proceeding northbound out of the Bishop area.

Both Mr. Arciero and Mr. Jernigan were placed under arrest for child endangerment and transported and booked into the Mono County Jail without incident. The case will be forwarded to the Mono County District Attorney's office. The juvenile was released to Mono County Child Protective Services who will reunite the juvenile with her mother.

This new boat will replace an older patrol boat that was taken out of service this past year. The new boat was purchased with grant funds from the California Department of Boating and Waterways.

The Mono County Sheriff's Office maintains a fleet of three patrol boats which monitor and patrol the lakes and waterways of Mono County. In doing so, our Office hopes that everyone safely enjoys the opportunities Mono County's waterways provide.

RE: Two Dead Mules found near June Mountain Ski Area

On Sunday, July 29th, 2012, at approximately 3:45pm, Mono County Sheriff's Dispatchers received a report of two potential dead mules in a holding area near June Mountain Ski Area.

Mono County Sheriff's Deputies arrived on scene and were met by members of the Frontier Pack Train. The Pack Train stated they had received a call informing them that it appeared two mules were lying dead in their holding area that was set up 8-days prior. The Pack Train confirmed that two mules had been killed inside their holding area and looked to have been dead for several days. The area around the holding area was searched by Mono County Sheriff Deputies with no evidence of foul play. The Pack Train stated that all the other mules and horses in the holding area were unharmed.

The incident has been forwarded to Mono County Sheriff's Investigators, along with the law enforcement officers from the U.S. Forest Service, to investigate the cause of death to the two mules.

RE: MONET Investigations lead to several arrests

On Wednesday, August 1st, and, Thursday, August 2nd, 2012, the Mono County Narcotics Task Force (MONET), with the assistance of the Mono County Sheriff's Department, the Mammoth Lakes Police Department, and the Inyo County Narcotics Task Force (INET), made seven narcotics related arrests.

On the morning of Wednesday, August 1st, MONET agents served a search warrant within the Town of Mammoth Lakes relating to the suspicion of sales of heroin and methamphetamine. The search warrant resulted in three arrests and the seizure of over \$4,000.00 in proceeds from the sale of the narcotics. Agents also recovered scales, packaging materials, large amounts of smoking devices, a firearm, prescription pills and methamphetamine. Benjamin John Pyorala, age 25, of Mammoth Lakes, was arrested for sales of heroin, possession of narcotics paraphernalia, possession of a controlled substance, and an addict in possession of a firearm. Steven Robert Mesa, age 26, of Mammoth Lakes, was arrested for possession of methamphetamine and possession of narcotics paraphernalia. Jose Cortez-Lugo, age 21, of Mammoth Lakes, was arrested for possession of narcotics paraphernalia.

In a separate investigation, on Wednesday, August 1st, Jessica Mari Schuricht, age 24, of Costa Mesa, was arrested for the possession and sales of morphine.

On Thursday, August 2nd, MONET agents arrested three subjects for the possession and sales of controlled substances.

Theodore Rauh, age 34, of Mammoth Lakes, was arrested for possession and sales of approximately 100 doses of LSD.

David Brandon Abruzzo, age 32, of Mammoth Lakes, was arrested for the sales of approximately 114 grams of psilocybin mushrooms. Mr. Abruzzo's arrest led to the service of a search warrant of his residence on Joaquin Street. MONET agents seized \$1,800.00 in

proceeds from the sales of the narcotics and recovered approximately 2,000 grams of psilocybin mushrooms, 150 doses of LSD, 985 grams of marijuana, 230 grams of hash, 5 grams of Ketamine powder, scales, and packaging material.

Peter Francis Jednak, age 21, of Mammoth Lakes, was arrested for the possession and sales of cocaine, psilocybin mushrooms, and marijuana.

All suspects were transported to the Mono County Jail without further incident.

RE: Marijuana Eradication in the Inyo National Forest

As part of the campaign of the Mono Narcotic Enforcement Team (MONET) to combat the cultivation of marijuana within Mono County, MONET agents, with the assistance of the Inyo Narcotics Enforcement Team, Inyo County Sheriff's Office, Mammoth Lakes Police Department, Mono County Paramedics, Mono County Public Works, California Highway Patrol, U.S. Forest Service, Bureau of Land Management, California Department of Justice (CAMP), and the U.S. Customs Service, eradicated a large marijuana operation located on Forest Service lands in the Inyo National Forest.

The eradication took place on Wednesday August 15th and Thursday August 16th 2012. Over two days, with the assistance of two helicopters and one fixed wing aircraft, law enforcement eradicated approximately 30,000 marijuana plants from a large grow site, which was approximately 1 ½ miles in length, with a potential street value of approximately \$108 million dollars.

During the eradication, two suspects were taken into custody within the grow site. The suspects were identified as Edilio Navarro age 34 of Lake Elsinore Ca. and Nemesis Venegas age 22 of Perris Ca. During the arrest five handguns and one rifle were also seized. There are still several outstanding suspects, who are believed to be armed. The suspects arrested have been booked in the Mono County Jail with bail set at \$50,000 and they could be ultimately charged in Federal Court.

With these types of illegal marijuana grow sites, public lands are routinely desecrated with garbage, piping material, etc. The U.S. Forest Service will return to the affected area and complete an extensive cleanup and restoration operation due to the destruction of public lands by these cultivators. The cleanup and restoration is not only time consuming, but labor intensive and is done at a high cost to the taxpayers.

MONET agents would like to warn outdoor enthusiasts of the dangers of locating one of these grow sites. If you see anything that looks out of place such as cleared areas of forest that should not be cleared, fertilizer bags, black plastic pipes, large camps that seem out of place, or actively growing marijuana plants, please immediately leave the area and note the location, if possible, and notify the appropriate law enforcement agency. These large scale marijuana cultivators are routinely armed and are known to protect the gardens in any way they can.

RE: MONET Search Warrant leads to Mammoth arrest

On Thursday, September 6th, 2012 the Mono County Narcotics Task Force (MONET), along with assistance from the Mono County Sheriff's Department and Mammoth Lakes Police Department, concluded an extensive investigation for the sales of cocaine in the Town of Mammoth Lakes.

On the morning of Thursday, September 6th, MONET agents served a search warrant in the Town of Mammoth Lakes resulting in the arrest of Jack Jerry Colby, age 70, of Mammoth Lakes for suspicion of sales of cocaine. The search warrant resulted in the seizure of over \$19,000 US currency which was proceeds from the sales of narcotics. Agents recovered scales, packaging materials, over one (1) and a half pounds of cocaine, one (1) gram of methamphetamine and a small amount of marijuana.



Mr. Colby was taken into custody at the Mono County Jail in Bridgeport and charges are pending with the Mono County District Attorney's Office.

RE: Update on Helicopter Crash

On Wednesday, September 19, 2012, at approximately 12:30pm, Mono County Sheriff's Department Dispatch received a call regarding a possible helicopter crash with reports that the helicopter was on fire.



Personnel from the Mono County Sheriff's Department, Mammoth Lakes Fire Department, Long Valley Fire Department, Cal Fire, U.S. Forest Service, and Mono County Paramedics were on scene and confirmed that a helicopter had crashed on Pole Line Road, southeast of Mammoth Lakes, near Deer Springs Road. The two occupants to the helicopter were taken via helicopter, from Asplundh Construction Corp. working on some power lines in the area, to Mammoth Airport where an ambulance was waiting to transport them to Mammoth Hospital

for evaluation. The two occupants sustained minor injuries from the result of the crash. The two occupants worked for Chesapeake Bay Helicopters, contracted by Southern California Edison.

The crash caused a small brush fire that is contained and burned approximately 1.5 acres. Fire crews stayed at the crash site over night for security of the area. Representatives from the NTSB and FAA will be arriving today to conduct a full investigation into what caused the crash.

RE: Avalanche Danger in Mono County

During the last series of storms to arrive in Mono County, a substantial amount of snow has fallen in the backcountry of Mono County. At times, the series of storms produced snowfall rates in excess of one inch per hour for twenty-four hours. Also, the accompanying winds with the storms provided for wind loading on the lee side of the mountains and ridge lines.

The early season snowfall has crystalized and formed an extremely smooth base for the new snow to rest upon. The recent heavy snowfall, high winds coupled with a smooth hard pack base has significantly increased the avalanche danger in the backcountry areas of Mono County.

Backcountry travel is NOT advised until the snowpack has settled and solidified. When traveling into the backcountry, please advise non-traveling friends and relatives with the following information:

1. Where are you going?
2. Who is going with you?
3. Does each member of the party have an Avalanche Beacon?
4. What time are you leaving?
5. What time do you expect to return?
6. Are you carrying a cell phone?
7. Where are you parking your vehicle for your journey?
8. Leave a legible note on the dash of your vehicle as to where you are going and your expected time of return.

These simple questions will help friends and family to decide to call for assistance, if the need arises. Also, the answers to these questions will assist Emergency Responders in their search effort, if the need arises.
